Subject: Agenda Item 4—Amend Pre-Plan Public Hearing Schedule & Add Post-Plan Hearing Sites

A. At its March 16, 2011 meeting, the Board adopted a pre-plan public hearing schedule that included, among other sites, a public hearing in Palmer and a public hearing in Kotzebue. All hearings were to run from 12:00PM to 7:00PM ADT. Because of scheduling conflicts, the schedule adopted by the Board should be amended to show the hearing in the Mat-Su region to be held in Wasilla and the hearing in Kotzebue to run from 1:00PM to 6:00PM. All other pre-plan hearing sites and times will remain as established on March 16, 2011. The amended schedule is attached.
